

FACTS WHAT DOES BKCO MORTGAGE, LLC (NMLS #1830969) DO WITH YOUR PERSONAL INFORMATION?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Credit history and credit scores
- Mortgage rates, mortgage payments, account balances, and payment history

How? All financial companies need to share customers' personal information to run their everyday business. What we do**How does BKCO MORTGAGE, LLC (NMLS #1830969) protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

ONLY AUTHORIZED EMPLOYEES ARE ALLOWED ACCESS TO YOUR INFORMATION WHEN NEEDED TO COMPLETE THEIR WORK. ANY COMPANY WE WORK WITH IS REQUIRED TO HAVE SAFEGUARDS TO PROTECT CUSTOMER INFORMATION.

How does BKCO MORTGAGE, LLC (NMLS #1830969) collect my personal information?

We collect your personal information, for example, when you;

- apply for a loan, or give us your income information
- provide account information, or show your driver's license
- provide employment information

We also collect your personal information from others, such as credit bureaus, affiliates, other financial companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes - information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account - unless you tell us otherwise.

Definitions**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- **BKCO MORTGAGE, LLC (NMLS #1830969) affiliates include financial companies such as STEARNS LENDING, LLC, TRIMAVIN, LLC, TRIVERIFY, LLC, and HOME SHIELD INSURANCE SOLUTIONS, LLC.**

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- **BKCO MORTGAGE, LLC (NMLS #1830969) does not share with nonaffiliates to market to you.**

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- **BKCO MORTGAGE, LLC (NMLS #1830969) does not jointly market.**

Other Important Information:
